MACEY'S A HIT FOR KANSAS!




Kansas Department of Wildlife, Parks & Tourism's (KDWPT) spring marketing campaign included digital, print and television-all supported by social media. Digital impressions were well over 30 million with nearly 26,000 clicks generating traffic to both TravelKS.com and KSOutdoors.com. The high-

light was the 6-year-old box of dynamite from Council Grove, Kan., Macey Hensley. TV impressions, alone, were 4.3 million, but the big news was the number of video views on Facebook. The "I Like Ike" :30 second commercial exceeded 157,000 views with nearly 1,300 post shares! The "Exploration Place" commercial had over 90,000 views. Macey also appeared on another episode of The Ellen DeGeneres Show and gave a great endorsement of Kansas, encouraging people to visit our state.

TravelKS.com web traffic was up 4.14% for the year with nearly 47% of those views from Kansans. Sessions by device showed desktop at 54%, mobile at 34% and tablet at 12%. As the use of mobile devices continues to rise, KDWPT anticipates the launch of the new TravelKS.com website on the responsive web design platform in mid-August. This platform adjusts the website content format to match the screen used by the viewer.

GOVERNOR CALLS SPECIAL SESSION



On Tuesday, June 7th, Governor Brownback announced he was calling legislators back to Topeka for a Special Session to address the May 27th Kansas Su-

preme Court ruling that the current school finance formula is unconstitutional because it is inequitably funded. The Court gave the Legislature until June 30th to remedy the funding or said it will close all schools effective July 1st. School supporters hoped the Legislature would address the ruling on June 1st when they returned for Sine Die, however, legislative leadership said there was not sufficient time to craft a fix to the Court's ruling and therefore took no action. After significant pressure from many Republicans running for reelection, and a petition started by the Democrats, the Governor called the Special Session.

This most recent school funding ruling from the Kansas Supreme Court deals with the equity portion of the school lawsuits (adequacy also is in question, but has yet to be taken up by the Court) and says the Local Option Budget (LOB) portion of the current K-12 finance system is unconstitutional. Essentially this ruling is over tax relief for poor districts with none of the money going to the classrooms, but instead being sent to districts not able to raise as much money as wealthier districts through their LOBs. Estimates range that at least another \$30-40 million is needed to equalize the funding throughout the state to satisfy the court. With state revenues already in the red, the sentiment has been there isn't state money to pay for this order without either cutting other areas of government or raising revenue (i.e. taxes), which is never popular in an election year.

To muddy the water even more, some legislators are unhappy with the Court's remedy to close schools when the amount of money needed is less than 1% of the overall school spending in the state and is more politically motivated. Others would like for the schools to close so there is the potential for the United States Supreme Court to review the case when the federally mandated programs, such as special education and free and reduced lunch, are not funded. However, those concerned with ramifications of schools actually closing as well as fear of facing angry voters during what is already a contentious election season, won the argument when the Governor called a Special Session.

Fortunately, a solution was reached after just a two-day Special Session with a fix that boosted equity spending by \$38 million for school year 2016-2017. The legislation ultimately passing received broad, bipartisan support that included a signed agreement between plaintiff's counsel and state officials that the legislation satisfies the court's order and will keep K-12 school doors open this fall.

House Bill 2001 passed the House by a vote of 116-6 and the Senate 38-1. The bill raises \$38 million in additional Local Option Budget state aid, which the court said was necessary to fully fund the old school finance formula and equalize the local option budgets across wealthy and poor districts. The \$38 million comes from a variety of funding sources:

- \$13 million Kansas Bioscience Authority sale proceeds above \$25 million
- \$10.5 million tobacco master settlement agreement
- \$7.2 million extraordinary needs supplemental school aid (\$15 million total in the fund)
- \$4.1 million shifting of Temporary Assistance for Needy Families (TANF) funds for a preschool pilot program
- \$2.8 million virtual school program state aid

The largest source of equity dollars comes from the Kansas Bioscience Authority (KBA) sale proceeds above \$25 million. Should the sale generate less than \$38 million, the bill triggers two mechanisms to make up for the shortage. Those include clearing out the \$7.8 million remaining in the extraordinary needs fund – dollars within the Kansas Department of Education that are available to school districts that experience sharp changes in student enrollment or property values – and \$5 million from the Kansas Department of Transportation's motor vehicle registration fund.

The original proposal introduced at the start of the Special Session drew \$13 million from cutting all school districts general state aid by .5%. The plan passed both the House Appropriations and Senate Ways and Means Committees on Thursday, but lost steam on Friday when a group of Legislators voiced strong opposition and began crafting the new plan.

Governor Brownback has stated that he supports the HB 2001and plans to sign the bill into law. Plaintiffs' attorneys in the school finance lawsuit and Kansas lawmakers have also signed a letter of support stating that the bill fixes equity and will meet constitutional muster.


TRAVEL INDUSTRY MAINTAINS HEALTHY PERFORMANCE IN MAY

From U.S. Travel

Food and beverage services and the airline industry saw growth, while lodging and entertainment experienced slight contraction.

Travel employment edged down by 900 jobs in May, according to U.S. Travel Association estimates. However, the travel industry added 15,300 jobs overall in the first five months in 2016.

Early June's jobs report form the Bureau of Labor Statistics indicates that growth in total nonfarm payroll employment slowed significantly last month, increasing by just 38,000 jobs in May. The overall employment rate, though, dipped to 4.7 percent.



The travel jobs added last month were mainly seen in the airline and food and beverage service industries. The lodging and arts/entertainment/recreation industries lost jobs in May.

Overall, the travel industry remains a consistent job creator for the current U.S. economy, adding new jobs 15 out of the last 20 months. Since the post-recession employment recovery began in early 2010, travel has outpaced job creation in the rest of the economy by 17 percent. The travel industry continues to support one in nine American jobs.

T-WORKS PROGRAM

What's left of the 2010 T-WORKS transportation program is essentially gutted by the actions of the Administration and the Kansas Legislature. Economic Lifelines Executive Director Mike Johnston calls it "an unnatural disaster" for transportation.

Johnston, former KDOT

Secretary and Kansas Turnpike Manager, said, "The continued drain on earmarked transportation dollars by the governor and legislature has finally required KDOT to downsize T-Works about which we have repeatedly warned."

Johnston noted that nearly \$300 million in preservation lettings were "delayed" in FY 16 and 17. These are essentially needed maintenance projects to keep existing roads and bridges in safe condition. KDOT sources say 1200 miles of maintenance has become 200, while bridge maintenance is cut in half.

Now because of the state's budget woes, 25 modernization and expansion projects totaling over half a billion dollars have also been "delayed." Some KDOT personnel are saying privately they may never be completed.

Johnston said, "Not only have these recent actions broken a promise to all Kansans, they also will have a profound negative impact on our state's economy. Jobs in the transportation industry create new wealth by using natural resources to create products that did not previously exist."

The Kansas Legislature and the Governor have diverted an estimated \$1.4 billion from transportation since 2011.

Meanwhile, following the adjournment of the Legislature, Moody's Investors Service adjusted Kansas highway revenue bonds outlook from stable to negative. That's due to \$185 million being diverted from KDOT in sales tax that was originally earmarked for transportation.

Moody's also changed the State of Kansas general outlook to negative.

"By continuing to balance its budget with unsustainable nonrecurring resources, including pension underfunding, it is accumulating large and expensive long-term liabilities that it will be paying off for a long time," Moody's said. CALENDAR OF EVENTS (CLICK ON EACH LINK FOR MORE INFORMATION):
