Michael,

Charter Ordinance No. 39 exempts the City of Lawrence from KSA 12-1697(a) and (d). KSA 12-1697(a) and (d) provide that a county or city may levy a transient guest tax of up to 2%. The charter ordinance replaces that provision with a 6% transient guest tax.

It looks like the remainder of the transient guest statutes still apply, including KSA 12-1698(e), which provides that “[a]ll such moneys received by the county or city treasurer from disbursements from the county or city transient guest tax fund shall be credited to the tourism and convention promotion fund of such county or city and shall only be expended for convention and tourism promotion.”
